The Office of the Rural Municipal Executive Baragadhi *has allocated funds or received a grant* from **Government of Nepal** towards the cost of Construction of (15-Bedded) Primary Hospital Building Ward No. -3, Baragadhi Rural Municipality and intends to apply part of the funds to cover eligible payments under the Contract **for Construction of (15-Bedded) Primary Hospital Building Ward No. -3, Baragadhi Rural Municipality, and identification number of Contract : BGRM/BARA/W/NCB/2079-080/01.** Bidding is open to all eligible as per Section V of bidding document.
2. **Baragadhi Rural Municipality Office of the Rural Municipal Executive, Khopawa, Bara Madhesh Pradesh, Nepal** invites electronic bids from eligible bidders for the **Construction of (15-Bedded) Primary Hospital Building Ward No. -3, Baragadhi Rural Municipality** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years:- **NRS 111,000,000.000.**
  - Minimum Work experience of similar size and nature: **[At least 1 (ONE) RCC- Framed Building contract within the last Ten (10) years, Value of 89,000,000.00 that has been successfully or is substantially completed.**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
  4. 6. Pre-bid meeting shall be held at **Baragadhi Rural Municipality, Meeting Hall** at **2079-09-01, 2:00 PM.**
7. Sealed or Electronic bids must be submitted to the office **Baragadhi Rural Municipality, Office of the Rural Municipal Executive Khopawa, Bara Madhesh Pradesh** through PPMO's e-GP system [www.bolpatra.gov.np/egpon](http://www.bolpatra.gov.np/egpon) before **12:00 hrs** on **2079-09-13.** Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hrs **2079/09/13** at the office of **Baragadhi Rural Municipality ,Khopawa, Bara Madhesh Pradesh.** Bids must be valid for a period of **120 day** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRS. 5,000,000.00**, which shall be valid for 30 days beyond the validity period of the bid .
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
10. **Field Visit report Compulsory should be submitted before pre-bid meeting and submission of bid.**
11. Office may cancel the bid and Procurement Process if necessary.
